## Chapter I

# The Human Condition

This book looks at both lifestyles of being married or remaining single. Marriage can be a blessing or a curse. Being single can be a blessing or a curse. The purpose of this book is to help the reader to see all the blessings and cursings of each lifestyle. It also helps the reader know more about themselves as to what they want and don't want for either lifestyle. The book provides the reality of marriage and remaining single, as opposed to our dreams and expectations, so that the reader can avoid making a foolish decision. The book provides wisdom to the reader so that they can make a wise choice for which ever lifestyle they would choose - because you must choose between one or the other. I attempt to discuss as many variables as possible that should be considered when deciding which lifestyle to choose from. I cannot cover all possible variables since there exist too many minor variables thus, I focus on the general variables. This book is not written to solve anyone's marriage problems, since I'm not a marriage counselor. Every relationship has many different challenges, circumstances, problems, and solutions. All relationships develop differently so what one solution will work with one will not work with another. Instead of solving marriage problems, this book provides a look at the two different

lifestyles – single or married – pros and cons – blessings and cursing's. The book can also provide a lot of answers to marriage and relationship problems but that is not the goal of the book.....

I'm going to begin with the subject divorce as strange as that seems. That's because divorce is what you never want to happen to you. The truth about divorce is not taught so, people do not know what is involved with a first time divorce. It's ugly.

There are two ways in which you can be divorced. Out-of-court settlement and In-court settlement. Out-of-court settlements only cost filing fees. You both decide on what to keep being fair about splitting moneys and belongs evenly. If you can do this, you both will walk away with 50% for each of you. This is a great way to get divorced since no one gets any of your money. An Out-of-court settlement requires that you both be fair with each other. Most people are too upset and angry so they are going to go through an In-court-settlement involving attorneys. They are usually attempting to get as much from the other as possible. Greed gets in the way. With an In-court-settlement and there are no children involved, the courts are going to attempt to divide everything in half-since you both refuse to do this. The courts have formula's that they use to help aid them in dividing belongings. One part of this formula involves the income of each spouse. With one spouse making more than the other then this effects the division of belongings. An out-of-court settlement does not consider each spouses income.

The bottom line with an In-court settlement is that both spouses are going to lose most everything. You must pay court fees, filling fees, and attorney fees. The attorneys are expensive and usually net 30% of the gross total of all belongings. Each attorney gets 30% thus an In-court-divorce is going to cost 60% (2 attorneys) of all gross moneys. That's just the beginning. When the divorce is final you will not have much left and will be starting all over in life. The house must be sold or bought out from a spouse, and the funds distributed among the attorneys as well as the spouses. Funds are also paid to the court and filing fees usually amounting to another 10%. The remainder 30% gets divided between the spouses which is 15% of remaining money. When children are involved, the courts also have a formula for them. Whoever gets to pay child support is worse off. Then there is alimony, retirement, and investments that are factored into this formula. It all gets very nasty. When the dust settles both spouses walk away with very little. This is one of the reasons that you don't want to go through a divorce. If a divorce is inevitable, then you **must** understand what your outcome is going to be and be prepared for that outcome. If you choose to be greedy you will lose everything - that's the reality of In-court-divorce.....

I'll begin the subject of marriage/single by discussing human emotions. Emotions are the biggest variable that plays with marriage. We humans have intellect and emotions – **surprise.** Emotions are wonderful but they can also be a curse. Emotions have no solid steady base within anyone. Emotions

come and go, they are up and down, they swing to the opposite very quickly. Emotions are difficult to control, thus, emotions cannot be trusted with anyone....

Physical feelings are not emotions. They all are cravings of our flesh. A lot of emotions can come to life from physical cravings. Physical desires are one and the same with physical cravings. When we are hungry this is a physical craving. When we have sexual desires, this is a physical craving. The physical cravings can bring on lots of cursing's to our life just as those cravings can be a blessing. Disciplining the physical cravings will keep the desires in check. Not disciplining the physical cravings will allow those cravings to rule your decisions. To give way to the physical cravings and satisfy them usually brings about cursing's. Controlling the physical fleshly appetites most always produces blessings. The wise control their physical desires while fools don't attempt to control their physical cravings. Controlling the physical cravings are actions that **must** be learned because it's not a natural ability. Those who can learn self-control will always be blessed. If you want to be blessed, then you must learn to control the physical cravings.

Being patient with your emotions along with logical thinking is going to be a blessing to you. Even better is having control over your emotions and physical desires. And remember this last insight; some people are very clever at hiding their faults for long periods of time. Unless you find someone, who is honest, up front, and tells you their .....

## Chapter 2

# Single verses Married

I will first cover the single life-style since most people do not take a close look at this style of life. Most people do not consider the pros and cons of being single. I'll start with the pros. Remaining single has lots of advantages. Once the reader sees what is required for marriage, they might seriously consider the single lifestyle. Marriage requires a lot of work and is limited with advantages and disadvantages, where being single has no requirements.

Remaining single is easy since there are no demands or requirements, no fuss, no buss. Once we look at all the pros and cons the reader might become excited at the single lifestyle. Once the reader can see all the blessing of remaining single, they will have an entirely different outlook with being single. It's difficult to sum up the pros and cons without looking at marriage as well. The reader will be better off looking at the marriage variables to use for comparisons.

One great pro is freedom. The single style does not have to be concerned about any of the marriage variables. One such variable is freedoms. By remaining single you get to enjoy a lot of freedoms where in marriage you lose a lot of those freedoms. A single person needs to understand the value of their freedoms. Freedom is something you shouldn't take lightly. No one can be

married and continue with the freedoms of the single life-style. Any time you lose a freedom you become a slave to the one who took your freedom. When you lose your freedoms, you are in bondage to the other plus you are at their mercy. Consider very carefully about sacrificing your freedoms.....

Most single people that are looking to marry and have grown up thinking that they must be married, yet have never considered the single lifestyle. Most have never even given any thought about the single lifestyle. What I'm attempting to do is rattle your cage and make you think about the single lifestyle – to take a serious look at the single life.....

A single person can accomplish many things because of their freedom. In marriage you will most likely have to forsake a lot of things you enjoy. Chances are that even projects your good at, the spouse isn't interested in them, thus the tendency will be to hold you back from pursuing your projects – this is the reality of marriage which you better consider really hard and very carefully.....

Almost every married person I know - their number one complaint is that they long for the freedom of not being held back from their projects..... Nine out of ten married couples that I know of tell me that they want out of marriage with their present spouse.....

Another pro is that of finances. All the money you make is yours. You don't have to pay for the other spouse. There is no one else to be a continual financial burden or strain. You only have one person to pay for - yourself. When married you have two people to pay for.....

One nice advantage or pro to remaining single is that you can do a lot of investing. Most working people don't make wealth just from a job. Most wealth comes through investing. Married people usually don't have money for investing because all their money goes to bills and monthly child expenses. There is always the exception for some married couples. The way to become wealthy is through investing and a single person has a better opportunity....

Another pro is having lots of friends. When people marry, their time becomes restricted with former friends. Marriage requires lots of your time. When single, you have lots of time and lots of friends and can do as you please. If you enjoy lots of friendships marriage will rob you of those friends. Consider carefully which you value more, lots of friendships or just one major friendship. In marriage your spouse is supposed to become your one main friend. That one main friend is going to require a lot of your time.....

Another con is regarding your finances. When you are married and you go places, like a restaurant, a movie, shopping, sporting events, etc. you must pay for 2 people. If you have children you must pay all the more.....

Another con to consider is the cost of a family. At today's costs to raise one child will cost from \$100,000 to \$250,000 up to \$500,000 for those 18 years of age.....

Another pro is being able to go places a lot. Married folks are limited to traveling because of time off from work and finances.....

## Chapter 3

### Finances

Finances are always a touchy subject when discussing marriage. Finances is another major variable that contributes to marriage and the single lifestyle. We all work to earn money, so the worker usually is the one who is also in charge of the finances. Every marriage handles finances differently. There are several schemes to handling finances which I'll attempt to cover. What will work with one couple will not work with another. There are several factors that determine which method each couple will choose to use. Trusting in the spouse, amount of income from each spouse, only one working spouse, the amount of time each spouse works, expenditures, hobbies, a business, a family business, size and price of a house, children, financial goals, investing, habits, to name a few. Some of the schemes that I cover can also be applied to those who choose the single lifestyle. If you're a single person it's good to review these different methods since you might see a few idea's that will enhance your financial wisdom. All these mentioned methods are aimed at married spouses since most all married couples must deal with financial decisions and difficulties.....

What I keep seeing again and again, is that newlyweds or marriages with financial problems, have not come together to discuss a financial plan. There are many factors to consider

when discussing a financial plan as mentioned below. I cover these schemes to give you some ideas of what to consider when making a financial marriage plan.....

Most married couples don't take the time to draw out a long-term plan. Instead, they just do things as each problem arises. These kinds of marriages are headed for financial problems. Zero planning for anything in a marriage, most always involves finances. Both spouses also need to include planning for the unexpected such as an auto accident or replacing a dying auto, a job lay-off, an accident that causes expensive hospital bills, or a natural disaster. Any type of unexpected financial costs will probably happen because this is the norm for most all individuals - married and single. When there is no planning and you're living by taking on each problem as they arise, you're only looking at how much remaining money you have for each month. When the next problem presents itself, the question that arises is what we can afford for this present problem or this need.....

With a financial plan you both know how much money you have in the pot each month. You'll know what items you can afford and if you stick strictly to that budget, you'll not have problems that others suffer. You'll know what your goals are and can both work to achieve those goals. With such a plan there will be little to none of the financial pressures and strains that can impact a marriage unless you deviate from the plan.....

## Chapter 4

### Problem Solving

Today, solving problems in any type of relationship is no longer taught. The generations since World War 2, has ceased from teaching much of anything regarding relationships and marriage. One of the variables not taught in relationships is problem solving. Solving problems is a critical requirement for marriages to succeed. If you never learn how to solve problems in any friendship or marriage that relationship or marriage is doomed for failure.

Today's society does the opposite of solving problems. People run from their problems because most people don't know how to solve problems. What makes runners so bad is that in the next relationship, they are going to encounter problems again and the cycle starts all over - not solving the problems but running from those problems. Runners continue to look for a new partner or spouse that can solve or prevent problems. In the end the cycle starts all over again. Later, runners learn to tolerate difficulties or problems. They ignore the problem and just don't discuss it anymore. In turn, that marriage or relationship stagnates – ceasing from developing into a deeper meaningful relationship.....

Every relationship is going to encounter problems and difficulties. There is no such thing as a problem free marriage. If

you're thinking that your perfect marriage will never have problems you're living in a dream world. Ask every married person about having marriage problems and you're going to quickly learn that every one of them has had problems or is having problems.....

Each spouse is going to have to learn and know how to solve their marriage problems. Any and most all problems cannot be solved by just one spouse. Both spouses must learn to work together at solving their problems. If one spouse does not learn to work with the other at solving their problems, then that marriage will eventually fail. Problem solving requires both spouse's input. It requires a strategy that both must formulate together and initiate together.....

Communication skills is an art that must be developed between spouses. You can't take for granted that the other knows what you're thinking. None of us are mind readers. I know lots of couples that make this error frequently. Both spouses must learn to spell out everything that they are thinking.....

Problem solving requires thinking skills. If you don't know how to think you're not going to solve any problems. You don't have to become a think tank like Einstein or Oppenheimer, but you do need basic thinking skills. You can learn from a few books or even from lessons off the internet. If your spouse has thinking skills that is a big green flag.....

## Chapter 5

### Culture

Every country is different in their cultures and traditions. Older countries, like Europe and the Middle East are more steeped in traditions than the newer countries like the USA and South America. The older countries carry far more meaning in their heritage, which makes them rather special with their history. These older countries pride themselves on their rich traditions as anyone would. For them, tradition and heritage are an important part of their culture.....

No matter where you go on the earth, all marriages encounter the same variables, the same challenges, the same struggles, the same conditions. One of the biggest observations I've made is that most cultures are different when it comes to pride versus humility. The way a culture develops is usually based upon these two traits. The degree of pride and humility will affect a marriage for better or worse. The more prideful a country is, the higher the divorce rate. The less pride the less the divorce rate. And this is the condition of the people of the USA, England, some of the European countries, and some of the Middle Eastern countries. They are full of pride and will never return to being humble. Knowing this situation in these countries should make you aware of the risk of divorce in those countries.....

## Chapter 6

### Like Interests

You should try to find a spouse with as many interests as you have. The more the interests the better and these likenesses can be counted as green flags. A spouse that has the same interests is going to be a big plus to any marriage. They will be involved in the projects you enjoy because they also will find much joy participating in the same likes. You both will play and work together with the same goals and projects. Your conversations will be more joyful and exciting.....

It's a rarity to find a spouse with many of the same likes let alone all the same likes. Should you find such a spouse they will make for a more meaningful marriage. There will be little contention between both of you. You will share all the equipment and time together. Your projects will be more enjoyable and meaningful. Goals and aspirations will be mutual making for a greater amount of joy and love for both spouses.....

When both spouses have only a few things in common they both attempt to tolerate the things that are not in common. Depending upon the tolerance levels, some can be okay with the other spouse. As time passes both spouses are going to become more involved with their projects. This can develop into problems because of financing those projects. What then comes into play is the fairness of being equal with the financing.....

## Chapter 7

### Soul Mates

For the past twenty years there has been a new belief throughout the earth which I'm going to discuss in this chapter. This belief is called Soul Mates. The belief is that there is just one person who has been destined for you and no one else. This belief involves that such a spouse is the ideal perfect person that is intended for you to be married to.

This soul mate belief is a false teaching, and I'll show you why. I'll use the Bible for an example and then some other examples. In the Bible you will never find God creating any one person to be married to another person except for Adam and Eve. You never find God match making or bringing two people together for marriage unless you give Him permission to do so. The Bible teaches that everyone has the freedom of choice which also applies to marriage. The Bible also teaches that it's a good thing to find a good spouse and that we can obtain blessings from marriage. The Bible further teaches spouses many aspects to have, to make for a better marriage. You can ask God for His advice about a potential spouse. Many of my Christian friends have had God say no, and some of them have had God say 'yes.' Most positive answers from God are more along the lines of 'that one has my approval.' Even with God's approval it's all your choice.....

Another example comes from what we witness in our lifetime. If the soul mate's belief is true, then why do I continue to witness people getting divorced who accepted this belief before they married? Then they get married again to another Soul Mate? Suddenly there are two soul mates. The belief now is altered to accommodate failure. The belief of Soul Mate is that the soul mate marriage will always last. No matter what happens, that spouse is your one and only spouse and that spouse will always defeat and conquer all differences and difficulties. The belief is based on a perfect dream person that is your ideal spouse. As discussed in chapter 2 – the ideal dream spouse does not exist. I know several people who adopted this belief only to watch them undergo divorce. After their divorce I would ask them about their soul mate marriage. The answer is always the same – I must have not met the soul mate; thus, this belief is always being altered. Today there exists all kinds of versions of the soul mate belief.....

God expects you to be wise and knowledgeable about marriage like studying this book. Once you have learned all that, you probably have 90% of what you need to know and will be accurate with a wise choice. My advice is to learn all you can about marriage and a potential spouse and then ask God for His opinion. You might find a seemingly great candidate who has lots of green flags and God may say no. You've done all your homework but still can't see something that God can see, and this is where He is wonderful at providing an answer. God is great at helping us avoid potential problems by providing .....

## Chapter 8

### Point of View

Points of view come from past experiences everyone has encountered throughout their life. As we age our experiences alter our thoughts and ideas. We learn more truths about life and many times what we once thought was correct turns out to be incorrect. We experience good situations and bad situations. Over time our ideas and points of view are developed and defined or redefined. This evolving occurrence is ongoing throughout our lifetime. The more we experience life the more defined we become.

When we engage in a relationship our points of view come into play. With a relationship we have two sets of points of view, two sets of beliefs, and two sets of past experiences. Part of a relationship is discussing our points of view to each other. These discussions are what makes for a wonderful relationship or causes a relationship to turn sour.

What you want to achieve is to be heard and to hear the other. When engaging in a conversation you want to learn to listen to the other and thoroughly understand all that they have said. In lots of conversations, we tend to be vague by either taking for granted that the other understands our thoughts or is just not being descriptive enough. When this occurs the other person must guess what you mean or try to figure out what you're

exactly saying.....

Marriage is another example of a viewpoint. There can be a lot of differences in decision making which requires thinking skills. There may be more than one solution to solving a problem or planning.

Points of view play a big role in relationships and marriage. Learn to recognize each other's points of view during a conversation. If you think or know that their view is wrong, be wise as to how to show them where they errored. Points of view can be sticky when attempting to correct the others' views. Remember that they had a past experience that molded their views. So, when listening to their view keep in mind that an experience is a powerful factor. It's that experience that you are dealing with. When you disagree with their view, or they disagree with your view try to view how their experience unfolded.....

## Chapter 9

### Baggage

**B**aggage is when people will not let go of former relationship or marriage memories. Hanging onto baggage is harmful and not wise. I'm continually amazed at how people can't let go of the memories. They have good memories and bad memories from a divorce. Baggage are memories that need to be dwelt with before entering a new relationship. Any time anyone brings up past memories in a new relationship the other person is going to feel like they are being compared to past memories whether they are bad or good memories. This is what anyone is doing by opening baggage. Unknowingly they are comparing a new relationship with the former relationship. How would you like to be compared to someone in the past? That former person is gone – over with. The person in the new relationship is going to start to be in competition with memories. How would you like being in competition with someone's baggage?

One of the most destructive methods to harm a new marriage is by bringing past memories of a former relationship to a new spouse. Just one sentence can do harm. Bringing up memories when dating is going to damage the other. No one including you, wants to hear about any of that persons past relationship. Instead, they want a new you that is healed and free

from the past, just as you also desire that from someone who was divorced. If you're divorced, the biggest lesson you must learn is to never bring up memories of a past relationship to anyone including the good memories. Even if the other one your dating asks, never talk about the past.....

You want to accomplish forgetting the good memories as well as the bad memories. There are three courses of action you need to employ to get free from past relationships – the ability to forgive, the ability to control your thinking of your past relationships, and the ability to forget. If you can achieve these three goals, you'll be free from any baggage. There are very few things sweeter in life than other things – one is to be free. You'll enjoy yourself and be happy with your life because of the freedom that you can gain from any baggage. Mental clinics and mental doctors and their medications can't do this for you because they either refuse to tell you or they just don't know what to do.....

I'll discuss how these three methods work. These three tasks are not easy and require work. They require time as well, so be aware that practicing these tasks is not going to heal you overnight. Depending on your ability to concentrate on these tasks can shorten your healing time.....

Forgiveness is powerful but it is very difficult to do. Forgiveness involves not holding any grudges, dislikes, hatreds, anger, hurts and memories towards any wrongs that people have done to us. We all experience wrongs that are done to us all the time. Forgiveness is not holding anything against.....

## Chapter 10

### Red Flags and Green Flags and Testing

Red Flags and Green Flags are our best tools for any relationship and especially for an engagement for marriage. The red flags notify us that something isn't right or is wrong. The green flags show us that everything is good and has exceptional strong points. All of us encounter people with red flags and green flags all the time. Surprisingly, most of us ignore the red flags when we are dating or become engaged. We can see the reds, but we want to think that they are just a temporary issue with the other person. Green flags are great, but they can be deceiving because our tendency is to focus upon them and ignore the reds. Rest assured the reds are not a temporary issue but a permanent part of the true nature of that person. Those who ignore the red flags because they are wanting to have ownership of the other person are going to be in misery after acquiring ownership. After a while, they are going to regret having ignored those red flags and will discover that having ownership of that person was not worth ignoring those red flags. With the greens, use them for highlighting those traits to enhance the rest of that person's personality. Testing for suspicious red flags is a healthy action to employ. Most people don't know about testing or are afraid to test another person. I refer to testing as a shield of protection for anyone's happiness and peace.

protection for anyones happiness and peace.....

Patience and red flags and green flags are the most important tools we need for friendships and marriage. You'll never go wrong by being patient and watching for red flags. One point, we all to need understand, is that in any kind of relationship (whether friendships or an engagement) we are going to find red flags in every person. We are all human and we all have errors, faults, and shortcomings – none of us are perfect. The ideal person you desire to be married to is not a perfect angel as you vision because we all have faults.....

There are all kinds of rankings for red flags. I use 3 categories of red flags: Extreme, Medium, and Small. For our purpose we must decide what red flags we can live with. An extreme red flag is a big negative that is going to cause a lot of problems and headaches and misery. With one or two extreme red flags you should seriously consider letting go of that potential spouse. The medium red flags are faults that we can tolerate. Depending on your irritation level you might survive with these faults, or you may not fare well with them. But remember that you will always have to tolerate the medium red flags which will get to you from time to time.....

Along with Extreme, Medium, and Small red flags, there can be a mixture of each category. You will have to weigh all the red flags and add up the score. There is no getting around red flags thus we must consider and determine all the red flags that we see.....

# Chapter 11

## Deception

I have mentioned, in a few previous chapters, the variable of deception. There isn't a whole lot to discuss about this variable. Deception is deception and it's ugly to see people deceiving others. Most all deception is for personal gains. I believe that every person who has lived and is living has been involved in some sort of deception. Deception comes in all forms and schemes. Deception always involves lying. Three types of lying are involved since all lying is categorized into three main categories.....

### First Type of Lying

One type of the most common lying, is an outright verbal lie. Outright verbal lying involves talking. It may be denying what a person is accused of – 'I didn't do it.' It may be giving false information. It may be fabricating a story to impress others. Most of the lying involves outright verbal lying. Most of the time this type of lie is to hide the truth from others. You don't want your evil deeds to be revealed. Or you want to impress others about your abilities and successes.....

## Chapter 12

### Testing and Detective

This chapter is more for individuals who believe that the person they are dating, engaged to, or married to is involved in some type of criminal activity, illegal activities, or is hiding various activities. You're wanting to learn the truth of their activities so that you can make a decision to break off that relationship to protect yourself from any harm or determine if your partner is innocent. In chapter 10, I discussed testing to determine red flags. Red flag testing doesn't always work for these types of activities and can be dangerous if your test is discovered. Trying to dig up information from the internet is only going to provide information about past actions. The internet can't reveal what present activities your partner is involved in. Doing any kind of detective work on your own will probably be discovered and can become dangerous.

This is when you want to hire a private investigator. PI's are going to cost some money and they all have different prices. There are all kinds of PI's that specialize in different kinds of investigations. And there are a lot of them that just are not very good. A good PI will have former experience with law enforcement or is involved with law enforcement. Attorneys hire PI's and even employ their own PI's. An experienced PI is usually a professional at what they do. Finding a good PI .....

## Chapter 13

### Marriage Counseling

When having marriage difficulties there is always the option of seeing a marriage counselor. Marriage counseling doesn't work for half the people who see a counselor - surprise. The best that a counselor can do is to reveal what you're doing wrong to the other person and how to stop doing those wrongs. If only one of you sees a counselor you're probably not going to resolve the difficulty. It's far better for both of you to see a counselor. For each discrepancy the counselor needs to see and hear the others' response. When only one person sees a counselor it's hearing only one side of the story. The counselor needs to hear both sides of the story. There are lots of counselors who are more than happy to take your money and give counsel to only one of the spouses. Be aware that if you see a counselor solo, you are going to receive some poor advice.

Receiving advice to stop performing a certain habit isn't going to get rid of that habit. You must deal with the core problem and most counselors don't do this nor do they know how to do this. Habits are most always a surface reaction to a deeper problem. If you cut a weed off at its base it will grow right back - you must pull the root out of the ground to rid the weed in the yard. Cutting off cigarettes from a smoker isn't solving the problem - you must deal with the addiction.....

## Chapter 14

# Communication

People marry for all kinds of reasons, but the most common reason is communication. We want to share experiences, laugh, have intellectual conversations, be heard, be taken care of, be offered wise advice, fellowship with family, learn new interests, share information, be warned, be helped, be a team worker, etc. All these reasons require communication. No one wants to marry a dead log and no one wants to marry someone who is constantly rambling.

For some people, communication is easy – no assembly required. They are natural at communication. Others need to develop communication skills – some assembly required. Many of us grew up being shy in school and have had a difficult time with shyness even after we become young adults.
